## Health Plan Oversight: How CMS Responds to Marketing and Enrollment Complaints at Two Levels

It's the time of year when beneficiaries are most vulnerable to misleading or mistaken claims that could lead them to select a plan that is not the best choice for them. SMPs should report enrollment and misrepresentation complaints promptly. These kinds of complaints often entail serious access-to-care issues that demand immediate attention. They also help CMS identify and rectify systemic problems.

### Beyond the AEP: Alternatives for Beneficiaries

There are options for beneficiaries who need to enroll in or change plans after the Annual Election Period ends December 7. Beneficiaries in plans that are not renewing have, in effect, an "extended" AEP. There are opportunities that arise immediately after the AEP as well as several other kinds of Special Enrollment Periods.

## Elder Financial Exploitation: A Growing Epidemic

Financial exploitation may cause seniors stress, depression, health issues, and lost time in addition to legal fees, bounced check fees, and lost wages. It disproportionately impacts minorities. There are networks in addition to SMP that are working to fight it that can be resources.
