Unwanted treatment undermines patient autonomy and causes needless pain and suffering. It is not reimbursable by Medicare and Medicaid as it is not "medically necessary," a required condition of both programs.

### Budget Endgame Unknown, but Anti-fraud Funding Expected to Survive

Both Congressional appropriations bills are expected to include the appropriate amount of discretionary funding for the HCFAC program, including an expansion of Strike Force cities to target Medicare fraud in high-risk areas and help achieve the president's goal of cutting the Medicare fee-for-service error rate in half by 2012.


## Partnerships, Praise at HHS Roundtable
